## Local/MEA/MEPA Scholarship Application Instructions

1. The application must be typed. You may use a typewriter; or you may fill in the form using Microsoft Word on the computer. Print a copy to turn into your counselor, but **DO NOT SAVE CHANGES WHEN YOU CLOSE THE FORM.** Please check in your school's counseling offices to ask if the scholarship application is available on the library computers, in the computer lab, or on other computers at the school. If you have a PC computer at home, you may want to request that a copy of the scholarship application be saved onto your computer disk so that you can work on it at home. 2. All questions must be answered. Only these forms can be used to record information for the local, MEA, and MEPA scholarships. Do not attach resumes or any extra sheets with additional information to this scholarship application.
3. Under No. 3, when listing such things as National Honor Society, list all years you have been a member. Consideration is given for each year of participation. The same applies for clubs, athletics, etc. Also, include offices held.
4. All local scholarship applications are to be returned to the counselors' offices by the end of January. You can turn this form in at later times; but in order for you to be considered by all organizations that use this form you need to submit your application in a timely manner.
5. Do not include your name or the name of any family member in any of the questions. The only place your name should be is on the last sheet of this packet.

If you are under 18, your parent must also sign.
